# PROPOSED RE-ELECTION OF RETIRING DIRECTORS AND PROPOSED GRANTING OF GENERAL MANDATES TO REPURCHASE SHARES AND TO ISSUE SHARES AND NOTICE OF ANNUAL GENERAL MEETING

#### 1. INTRODUCTION

The purpose of this circular is to provide the Shareholders with information in respect of certain resolutions to be proposed at the Annual General Meeting to be held on 23 May 2017.

#### 2. PROPOSED RE-ELECTION OF RETIRING DIRECTORS

In accordance with Article 87 of the Articles of Association, Mr. Yang, Tou-Hsiung, Mr. Yang, Cheng, Mr. Yang, Kun-Hsiang and Mr. Chen, Joen-Ray shall retire at the Annual General Meeting. All of the above retiring Directors, being eligible, will offer themselves for re-election at the Annual General Meeting.

Mr. Chen, Joen-Ray who has been serving as Independent Non-executive Director for more than 9 years, has confirmed his independence with reference to the factors set out in Rule 3.13 of the Listing Rules. The Company considers Mr. Chen, Joen-Ray is still independent in accordance with the independence guidelines set out in the Listing Rules and will continue to bring valuable business experience, knowledge and professionalism to the Board for its efficient and effective functioning.

Details of the retiring Directors are set out in Appendix I to this circular.

#### 3. PROPOSED GRANTING OF GENERAL MANDATE TO REPURCHASE SHARES

(1) **Mr. Yang, Tou-Hsiung**, 74, the Chairman and an Executive Director. Mr. Yang, Tou-Hsiung graduated from Taichung Min Der Commercial Vocational High School. Mr. Yang, Tou-Hsiung has approximately 54 years' working experience in the MSG industry and is one of the founders of the Taiwan Vedan Group. Mr. Yang, Tou-Hsiung is responsible for formulating the Group's overall corporate strategy. Mr. Yang, Tou-Hsiung is also an executive director of Taiwan Amino Acid Manufacturers Association.

Mr. Yang, Tou-Hsiung is a director of Vedan Vietnam, Billion Power and Taiwan Vedan. Mr. Yang, Tou-Hsiung indirectly holds approximately 19.77 per cent. interest in Taiwan Vedan. Mr. Yang, Tou-Hsiung is also a director and a shareholder of King International, a company which is beneficially owned by Mr. Yang, Tou-Hsiung as to 65 per cent. King International, Billion Power and Taiwan Vedan, together with various other parties, are the controlling shareholders of the Company. Mr. Yang, Tou-Hsiung is a member of the Yang Family. Mr. Yang, Kun-Hsiang indirectly holds approximately 6.18% interest in Taiwan Vedan. Mr. Yang, Kun-Hsiang is also a director and a shareholder of Concord Worldwide. Concord Worldwide, Billion Power and Taiwan Vedan, together with various other parties, are the controlling shareholders of the Company. Mr. Yang, Kun-Hsiang is a member of the Yang Family. Mr. Yang, Kun-Hsiang is the elder brother of Mr. Yang, Kun-Chou and the cousin of Mr. Yang, Tou-Hsiung, Mr. Yang, Cheng and Mr. Yang, Chen-Wen. Mr. Yang, Tou-Hsiung, Mr. Yang, Cheng, Mr. Yang, Chen-Wen and Mr. Yang, Kun-Chou are Executive Directors.

Mr. Yang, Kun-Hsiang has entered into a service agreement with the Company for a term of three years commencing on 27 June 2003 and thereafter shall continue from year to year until terminated by the giving of not less than three months' prior notice in writing thereof by either party to the other. In accordance with the service agreement, Mr. Yang, Kun-Hsiang is entitled to an annual remuneration of US\$250,000. After each completed year of service, the remuneration payable to Mr. Yang, Kun-Hsiang may, subject to the discretion of the Directors, be increased by not more than 15 per cent. He is also eligible to a discretionary bonus as the Board may determine, the amount of which is computed based on the Adjusted Profit and the specified percentage applicable to each level of the Adjusted Profit. Mr. Yang, Kun-Hsiang is also entitled to reimbursement of traveling expenses in the sum of US\$3,000 per quarter of each year of service. Mr. Yang, Kun-Hsiang was entitled to director's emoluments of US\$1,100,000 for the year ended 31 December 2016. The emoluments of Mr. Yang, Kun-Hsiang have been determined by the Company with reference to his qualification and experience, responsibilities undertaken, contribution to the Group, and the prevailing market level of remuneration for executives of similar position.

The emoluments of Mr. Chen have been determined by the Company with reference to prevailing market standards.

## EXPLANATORY STATEMENT ON THE SHARE BUY-BACK MANDATE

The following is an explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the Annual General Meeting in relation to the granting of the Share Buy-back Mandate.

#### 1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 1,522,742,000 Shares.

Subject to the passing of the ordinary resolution set out in item 5 of the notice of the Annual General Meeting in respect of the granting of the Share Buy-back Mandate and on the basis that no further Shares are issued or repurchased before the Annual General Meeting, i.e. being 1,522,742,000 Shares, the Directors would be authorized under the Share Buy-back Mandate to repurchase, during the period in which the Share Buy-back Mandate remains in force, a total of 152,274,200 Shares, representing 10% of the total number of Shares in issue as at the date of the Annual General Meeting.

#### 2. REASONS FOR SHARE BUY-BACK

The Directors believe that the granting of the Share Buy-back Mandate is in the best interests of the Company and the Shareholders.

Shares buy-back may, depending on the market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share and/or earnings per Share and will only be made when the Directors believe that such a buy-back will benefit the Company and the Shareholders.

#### **3. FUNDING OF SHARE BUY-BACK**

The company may only apply funds legally available for share buy-back in accordance with its Memorandum and Articles of Association, the laws of Cayman Islands and/or any other applicable laws, as the case may be.

#### 6. GENERAL

To the best of their knowledge and having made all reasonable enquiries, none of the Directors nor any of their respective close associates (as defined in the Listing Rules) have any present intention to sell any Shares to the Company in the event that the granting of the Share Buyback Mandate is approved by the Shareholders.

(a) Billion Power, Concord Worldwide, High Capital, King International, Mr. Yang, Tou-Hsiung, Mr. Yang, Cheng, Mr. Yang, Kun-Chou, Mr. Yang, Kun-Hsiang, Mr. Yang, Yung-Huang, Mr. Yang, Yung-Jen, Mr. Yang, Chen-Wen, Mr. Yang, Tung, Mr. Yang, Wen-Hu, Ms. Yang, Wen-Yin, Ms. Yang, Shu-Hui, Ms. Yang, Shu-Mei and Taiwan Vedan, the controlling shareholders of the Company as defined in the Listing Rules, were interested in 936,408,000 Shares representing approximately 61.49% of the total issued share capital of the Company. In the event that the Directors exercise the proposed Share Buy-back Mandate in full, the aggregate shareholding of such controlling shareholders would be increased to approximately 68.32% of the issued share capital of the Company.
