As a majority of the votes were cast in favour of each of the resolutions numbered 1 to 7, all resolutions were duly passed as ordinary resolutions.

As at the date of the AGM, the total number of shares of the Company in issue was 1,522,742,000 shares. The total number of shares of the Company entitling the holders to attend and vote on the resolutions at the AGM was 1,522,742,000 shares. There were no shares entitling the holder to attend and abstain from voting in favour of the resolutions at the AGM as set out in rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”).

No shareholder of the Company was required under the Listing Rules to abstain from voting on the resolutions at the AGM. None of the shareholders of the Company have stated their intention in the Company’s circular dated 20 April 2017 to vote against or to abstain from voting on any of the resolutions at the AGM.

The Company’s branch share registrar, Tricor Tengis Limited, acted as the scrutineer for the vote-taking at the AGM.

PAYMENT OF FINAL DIVIDEND

In relation to the ordinary resolution numbered 2 above, the final dividend of 0.837 US cents per share for the year ended 31 December 2016 will be paid in HK dollar (“**HK\$**”) on or around 9 June 2017 to the shareholders registered on the register of members of the Company on 31 May 2017. The HK\$ equivalent of the final dividend is 6.491 HK cents per share, which is based on the exchange rate of US dollar (“**US\$**”) against HK\$ at US\$1.00 to HK\$7.755 as quoted by The Hong Kong Association of Banks on 23 May 2017.
